
Public School and Your Rights

Under the federal McKinney-Vento Act

If

- Your family lives in a shelter
- Your Family lives in a motel or campground due to not having a fixed or stable living situation
- Your family lives in a car, park, abandoned building, or train station
- Your family lives with other people due to loss of housing or economic hardship

Then

- Your child is eligible to receive a free, appropriate education
- Your child has the right to enroll in school immediately, even if lacking documents usually required
- Your child may enroll and attend school while you and the school gather needed documents
- Your child may be enrolled in the local school or their school of origin (the school attended when permanently housed or the school they were last enrolled in), if that is your preference and it is feasible
 - If the district believes that your selection is not in the best interest of your child, then they must provide a written explanation and inform you of your right to appeal its decision
- Your child can receive transportation to and from school of origin, if you request this
- Your child can receive educational services comparable to those provided to other students

Housing and Educational Rights

Students without fixed, regular, and adequate nighttime residences have the following rights:

Immediate enrollment in the school they last attended or the local school where they are currently staying even if they do not have all of the documents normally required at the time of enrollment without fear of being separated or treated differently due to their housing situations;

Transportation to the school of origin for the regular school day;

Access to free meals, Title I and other educational programs, and transportation to extra-curricular activities to the same extent that it is offered to other students.

What questions would be helpful to ask when I enroll?

- » Who is the local homeless education liaison? How can I contact him or her?
- » What transportation is available for my child to stay in the same school (the school of origin)?
- » If my child changes schools, who can help us transfer records to the new school quickly?
- » How can my child receive free meals at school?
- » How can my child receive free school supplies, if needed?
- » Who can help if my child needs special education services? How quickly can these services be set up?
- » What academic help is available for my child, such as Title I programs or after-school tutoring?
- » What programs can help develop my child's talents and address his/her unique needs?
- » Are there sports, music, or other activities available for my child, and is there transportation available?
- » How can my child go on class field trips or participate in other school activities if I can't pay for them?
- » Is there a preschool program for my younger children, under four?
- » If school uniforms are required, is there a way to get help getting them?
- » Do you have a list of local resources?
